About the Arkansas Council

The Governor's Council on Developmental Disabilities Arkansas (GCDD or the Council) works to improve the independence and productivity of Arkansans with intellectual and developmental disabilities (IDD) and to ensure their inclusion and integration into the community. Key activities include:

- · Increasing and strengthening self-advocacy participation across the state
- Supporting programs to identify and remove barriers to information, services, and supports
- Advocating for policy changes to increase competitive, integrated employment
- · Developing and supporting coalitions
- Encouraging advocacy to keep policymakers informed about disability issues

The Council consists of 23 members, appointed by the Governor. Members include:

- Individuals with intellectual and developmental disabilities
- Family members of individuals with developmental disabilities
- Directors of state agencies that serve people with disabilities
- Representatives from nonprofit and private organizations that provide services and support for people with disabilities

In 2022, the Council celebrated 50 years of service to the Arkansas IDD community.

Founded in 1972 and still advocating!

GCDD is supported by an administrative staff including an Executive Director, a Deputy Director, a Program Coordinator, a Finance & Operations Coordinator, and an Administrative Assistant. Staff carries out the day-to-day operations to implement the state plan.

State councils on developmental disabilities, such as GCDD, are federally funded, self-governing organizations. GCDD is funded by a grant from the U.S. Department of Health and Human Services Administration on Community Living (ACL) through the Administration on Disability's Office of Intellectual and Developmental Disabilities (OIDD).

From the Director

On behalf of the Arkansas Governor's Council on Developmental Disabilities (GCDD) I am pleased to present our Annual Report for the Fiscal Year ending June 30, 2022. It shares the multiple achievements of the Council, Council Staff, and our valued Sub Grantee partners.

Fiscal Year 2022 is GCDD's first full year of work post-COVID, and the long-term impacts of the pandemic are still being measured. However, COVID taught us many

lessons as well. One of the biggest lessons learned in FY22 was the power of in-person connections. While virtual communication has become common, the most significant progress came from person-to-person meetings. Of those meetings, the Disability Policy Workgroup was the one most productive.

The Disability Policy Workgroup was composed of Council members, Council staff, and other stakeholders in the Arkansas disability community. It was assembled to discuss, explore, and prioritize issues with the greatest impact to Arkansans with disabilities, as well as the families and caregivers who support them. Ultimately, the group decided on five priorities that were endorsed by the Arkansas Disability Policy Consortium. Those priorities became the Arkansans Disability Policy Platform.

Arkansas Disability Policy Platform

People with disabilities have the right to live, learn, work, and play freely in Arkansas. For that to happen our State must commit to providing quality, inclusive home and community-based services that address:

- The catastrophic workforce shortage.
- Individual's right to make decisions about one's own life.
- Safe, affordable, and accessible housing.
- Opportunities for real work for real pay.
- Safe, comprehensive, and inclusive education for every student.

Resolving these issues will empower Arkansans with disabilities to fully participate in life in the Natural State.

These five principles help guide the work of the Council as we continue to work towards an Arkansas where people with disabilities can build a life where they feel included, integrated, and independent.

As Executive Director of the GCDD, I am grateful for the privilege of serving the Council and people of Arkansas. And on behalf of the Council, we are all grateful to continue working towards the inclusion, integration, and independence of Arkansans with disabilities.




FINANCIALS

Council Financial Information


The GCDD is funded under the Developmental Disabilities Assistance and Bill of Rights Act, known as the DD Act, (Public Law 106-402). GCDD's DD Act funding is administered through the U.S. Department of Health and Human Services by the ACL and is accessed through our designated state agency (DSA), the Arkansas Department of Finance and Administration. The Council reports annually, on three (3) fiscal years of finances, in the PPR.



Program Performance Report

The purpose of the PPR is to document DD Council results, outcomes, and impacts of Council work that occurred during the previous federal fiscal year.

The state plan required no amendments during the FY22 reporting period.

FUNDED PROJECTS FFY2022

The Council supported a variety of projects across the state in the 2021-2022 reporting period through our grant programs.

- The Marshallese Interpreting for Community Inclusion (MICI) Project To provide information/training on available community resources & reach under-served individuals & families. This project is a collaboration of Partners for Inclusive Communities, the Marshallese Educational Initiative (MEI), and SeSo, Inc. to provide interpreter training for bilingual adults who are fluent in Marshallese and English, as well as provide intercultural trainings for disability service providers. - The Reducing Barriers NWA Project To serve & support Marshallese &
 Latino/Hispanic families who have limited English proficiency, have intellectual &
 developmental disabilities (IDD) or have youth with IDD overcome challenging barriers to
 information & services within the community. CONTINUATION (COMPETITIVE)
- The DD Network New Advocacy Initiative To create an active alliance of advocacy programs that work together to give self-advocates, parents and peer advocates and state leaders the tools they need to be active within the disability advocacy movement; the project will provide leadership training, organizational training & support and disability advocacy education. Disability Rights Arkansas and the GCDD Arkansas will work with the Arkansas Alliance for Disability Advocacy (AADA) to operate and manage the Self-Advocacy Network Development Program, the Community of Champions Program and the Partners in Policymaking Arkansas Program.
