## Ñāāt juon ej aikuj juon Guardian ak Rilale?

An jab maroñ kōṃṃan jabdewōt ej itok jān joñan an juon armej nañinmej, an ṃwilin im kōjṃmāñļokjen jberbal. Emaroñ bar men in aikuj eļaññe armej eo ej juon minor ak juon ajiri. Aikuj bōk ñan court mokta jān jitōñe ak kālete juon guardian/rilale.
